Julius Sisiku Ayuk Tabe, 53 ans, président de ce micro-État autoproclamé, et son état major, réclament d'abord une « ***amnistie à toute la diaspora anglophone afin de permettre à ses ressortissants de regagner le pays sans être inquiéter*** »; « ***la libération de tous ceux qui ont été arrêtés dans le cadre du conflit; de l'acceptation par le gouvernement camerounais de participer à des négociations véritables sans conditions en terrain neutre et avec un médiateur défini de commun accord*** ». Tout ceci, écrivent-ils, doit se faire sous le regard gendarme des Nations unies.

**INTERIM GOVERNMENT OF AMBAZONIA STATEMENT ON ONGOING
CONSULTATIONS WITH STAKEHOLDERS AND FEEDBACK**

Fellow Ambazonians,

On Thursday, 2 July 2020, Ambazonia president, Sisiku AyukTabe, led a team of Southern Cameroons leaders in detention to a meeting with representatives of the regime in Yaoundé. The meeting was within the context of a call made by the UN Secretary General for a ceasefire in the on-going war in Ambazonia.

Since the meeting, the Interim Government of Ambazonia has consulted extensively with other frontline organisations and the civil society of our struggle on the establishment of a working platform intended to yield the best outcomes for the Ambazonian people. So far, the Interim Government of Ambazonia has reached out to:

***Ambazonia Gov. Council (AGovC)
The Consortium
Coalition for Dialogue and Negotiation
Ambazonia Restoration Forces***

***The Clergy and Faith Groups
Ambazonia Chiefs and Fons
Ambazonia Civil Society Groups
Ambazonia Community leaders***

During consultations with the aforementioned groups, the Interim Government of Ambazonia presented the four points tabled to the regime in Yaoundé by our leaders.

- **Declaration of ceasefire by LRC and withdrawal of its military from our streets.**
- **Release of all persons arrested in connection with this conflict.**
- **Granting of general amnesty to all in the diaspora to be able to return home without harassment**
- **Acceptance by the LRC to participate in a genuine negotiation without preconditions, in a neutral venue and mediated by a mutually agreed credible international mediator with a clear timetable acceptable to both parties.**

The following points were raised by the other frontline movements during our discussions; **(i)** the need to include a UN Fact Finding & Monitoring Mission (FFMM) into the 4 point request, to ensure adherence and monitoring; **(ii)** the focus on our overriding message and not the messenger; so that anyone called upon could deliver the same message; **(iii)** the need for international community's participation as the regime in Yaoundé cannot be trusted to keep its word.

Our fundamental goals are freedom and independence and we remain committed to attaining them.

THE RESPONSE TO A GLOBAL CEASE FIRE AS CALLED BY THE UNITED NATIONS

- Mindful of the UN/AU 2020 vision on Silencing Every Guns by 2020
- Mindful of the UN Secretary General's call for a global cease fire on July 1, 2020
- Mindful of United Nations Resolution 2532 on Global Ceasefire
- Mindful of the Conditions laid down by the Ambazonian Leadership in Detention to the Government of Cameroun following the call of the UN Secretary General on a global ceasefire
- Mindful of the fact that all wars end on the negotiations Table,

We the undersigned Ambazonian Prisoners of Conscience locked up as a result of the conflict since November 30, 2017 when President Paul Biya of Cameroun declared war on the people of Southern Cameroons, hereby align ourselves to the conditions laid down by the Ambazonian leadership in detention led by Sisiku AyukTabe for effective negotiations and a cease-fire.

We stand unapologetically to the conditions already laid down as follows:

- 1- The withdrawal of all Cameroun military, trucks and gear from our streets and villages back into their barracks
- 2- The Unconditional release and general amnesty of all detainees arrested because of the conflict and locked up in the various detention centres of Cameroun.
- 3- The granting of an amnesty for all Ambazonian refugees around the world to come back home without fear of police harassments.
- 4- The setting up of a time frame for negotiations in the presence of a third party on a neutral soil.

We believe that the above measures if implemented will go a long way to put an end to the four years that has caused untold sufferings to the population.
